As a Food Truck Vendor, you are required to supply all tables for condiments and supplies, and any additional electrical requirements as needed for your food truck. You are responsible for placing all garbage in the appropriate bins, and it is your responsibility to ensure proper disposal of used grease and oil from the Fairgrounds.
